2.3 License Required

2.3.6 Each health care entity applying for initial licensure shall submit a distinctive license name that does not mislead or confuse the public regarding the type of health services to be provided. the entity name need not include the services to be provided. If, however, those services are included in the name, that inclusion shall not mislead or confuse the public. Duplication of an existing name is prohibited except between health care entities that are affiliated through ownership or controlling interest.

103(2)(f) Other License Fees

- (A) Any facility applying for a change of address, shall submit a fee of \$75 with the application.
- (I) For purposes of this subsection, a corporate change of address for multiple facilities shall be considered one change of address.
- (B) Any facility applying for a change of name shall submit a fee of \$75 with the application.

CHAPTER XXVI - Home Care Agencies

5.4.8 Change of name and change of address fees
