Subject: **Request for a Public Rulemaking Hearing**
Proposed Amendments to 6 CCR 1009-2, The Infant Immunization Program and Immunization of Students Attending School, for the rulemaking to occur in May 2016.

In preparation for the Request for a Public Rulemaking Hearing, please find copies of the following documents: Proposed Amendments to 6 CCR 1009-2, Statement of Basis and Purpose and Specific Statutory Authority, Stakeholder Comment, and Regulatory Analysis.

Specific legal authority is established in Colorado statute with the expressed purpose of protecting students and the general population from vaccine preventable disease. Child care facilities, schools, and colleges/universities are bound by statute to ensure that students meet the immunization requirements as guided by the Colorado Board of Health (BOH).

Through a rulemaking in 2014, this rule incorporated by reference the Advisory Committee on Immunization Practices (ACIP) recommended vaccine schedules and removed a complicated chart listing the required doses. Since then, the response from school nurses, parents and providers has largely been favorable as it aligns the number and spacing of required doses with the national ACIP recommended vaccine schedule. Nonetheless, some are still experiencing confusion regarding how many doses of specific vaccines are due prior to kindergarten entry and sixth grade. The Department has proposed some additional language that clarifies the requirements for these students.

The Department has also received feedback that some colleges and universities continue to have questions about the aggregate reporting requirements and the Department is currently studying this. If the BOH is willing to allow a rulemaking hearing, additional proposed changes to clarify the requirements for colleges and universities may appear in the hearing packet.

In addition to addressing the requests from these stakeholders, these proposed amendments incorporate by reference the 2016 ACIP recommended vaccine schedules, clarify when non-medical exemptions expire, and clarify which schools must send statistical data to the Department.

In total, these proposed amendments continue to bring clarity to the rule and minimize potential confusion among end-users of the rule. As always, the Department will continue to solicit and incorporate stakeholder feedback.



**STATEMENT OF BASIS AND PURPOSE
AND SPECIFIC STATUTORY AUTHORITY**

for Amendments to

6 CCR 1009-2, The Infant Immunization Program and The Immunization of Students Attending School
March 16, 2016

Basis and Purpose.

Colorado requires all students to be immunized per the vaccine schedule established by Colorado Board of Health (BOH) rule 6 CCR 1009-2, upon school entry. The purpose of the immunization requirements for school entry is to protect students, staff, and the visiting public against vaccine-preventable diseases within schools. Accordingly, Colorado's immunization requirements have contributed to higher vaccine coverage and lower levels of vaccine preventable disease.

This rulemaking addresses feedback from stakeholders. Since 2014 when this rule incorporated by reference the Advisory Committee on Immunization Practices (ACIP) recommended vaccine schedules, the response from school nurses, parents and healthcare providers has largely been favorable as it aligns the number and spacing of required doses with the national ACIP recommended vaccine schedule. Nonetheless, some are still experiencing confusion regarding how many doses of specific vaccines are due prior to kindergarten entry and sixth grade. Proposed amendments address this concern and clarify the requirements for these students.

In addition to addressing this request from school stakeholders, these proposed amendments incorporate by reference the 2016 ACIP recommended vaccine schedules, clarify when non-medical exemptions expire, and clarify which schools must send statistical data to the Department. In total, these proposed amendments will bring clarity to the rule and minimize potential confusion among end-users of the rule.

The following changes to the rule are being proposed:

- Section II (B and C) - Proposed new language to clarify when non-medical exemptions expire. Prior to kindergarten, each non-medical exemption will expire at the time the next immunizations are due according to ACIP schedule and when the student is enrolled to attend kindergarten. From kindergarten through twelfth grade, a non-medical exemption will expire on June 30th, the last official day of each school year (June 30).
- Sections II (B and C), and III (B) - Proposed language updates the rule to incorporate by reference the 2016 ACIP schedules.
- Section III (C) - Proposed language to clarify that students between the ages of 4 through 6 years are required to receive their final doses of Diphtheria, Tetanus, and Pertussis (DTaP), Inactivated Polio Vaccine (IPV), Measles, Mumps, and Rubella (MMR) and Varicella at Kindergarten entry.
- Section III (D) - Proposed language to clarify that students are required to have one dose of Tetanus, Diphtheria, Pertussis (Tdap) at 6th grade entry.
- Section VII - Proposed language to clarify that all child care centers, preschools, public, private, or parochial schools with grades K - 12, and head start programs with 10 or more students shall send aggregate immunization and exemption data, by antigen, to the Department. Schools not required to send aggregate data to the Department: include before and after school programs, drop-in centers, day treatment centers, foster care homes, summer camps, day camps, and resident camps.
- Section IX (A) correct a typo to the date by inserting a space before "2016" in paragraph (A)(3).
- Section IX (F) modify to align this paragraph with the parallel language in Section VII.

REGULATORY ANALYSIS

for Amendments to

6 CCR 1009-2, The Infant Immunization Program and The Immunization of Students Attending School
March 16, 2016

1. A description of the classes of persons who will be affected by the proposed rule, including classes that will bear the costs of the proposed rule and classes that will benefit from the proposed rule.

The classes of people affected by the proposed amendments to the rule are students immunized against vaccine preventable diseases as required for school attendance and their parents or legal guardians, students with exemptions from required vaccines and their parents or legal guardians as well as health care providers, local public health agencies, school nurses, childcare health consultants and other school staff who ensure that students are appropriately vaccinated for attendance at Colorado schools.

School nurses, childcare health consultants, health care providers, local public health agencies and other school staff who ensure that students are appropriately vaccinated for attendance at Colorado schools will benefit specifically from the proposed amendments to this rule as the proposed amendments clarify the requirements for students prior to entry into kindergarten and sixth grade.

The other amendments proposed in the rule update the rule to the 2016 ACIP schedules, and offer clarification. There will not be a burden of increased costs for any class of people.

2. To the extent practicable, a description of the probable quantitative and qualitative impact of the proposed rule, economic or otherwise, upon affected classes of persons.

The proposed amendments are for the purposes of clarification; positively impacting end-users of the rule by making it easier to implement.

3. The probable costs to the agency and to any other agency of the implementation and enforcement of the proposed rule and any anticipated effect on state revenues.

As the proposed amendments do not add new requirements and largely seek to clarify existing requirements, there is no anticipated cost of compliance with the proposed amendments to the rule. There will be no anticipated effect on state revenues.

4. A comparison of the probable costs and benefits of the proposed rule to the probable costs and benefits of inaction.

There are no costs of compliance with the proposed amendments to the rule; the proposed amendments do not add any new substantive requirements. The benefits of the proposed amendments include bringing clarity to and reducing confusion for the end users of the rule.

5. A determination of whether there are less costly methods or less intrusive methods for achieving the purpose of the proposed rule.

The proposed amendments to the rule are not intrusive because the proposed amendments are expected to provide clarity to end users of the rule. Furthermore, the proposed amendments should strengthen our partnership with our community stakeholders in schools and childcares as the proposed amendments address their concerns or need for clarification. The proposed amendments have no anticipated cost.

6. Alternative Rules or Alternatives to Rulemaking Considered and Why Rejected.

The only alternative considered was to leave the rule as adopted. This was rejected due to the feedback received from stakeholders at schools and childcares across Colorado.

7. To the extent practicable, a quantification of the data used in the analysis; the analysis must take into account both short-term and long-term consequences.

Data used in this analysis included emails and conversations with school nurses, childcare health consultants, health care providers, local public health agencies and other staff who ensure that students are appropriately vaccinated for attendance at Colorado schools.

The proposed amendments were developed based on feedback received from our stakeholders, specifically school nurses, childcare health consultants and other staff who ensure that students are appropriately vaccinated for attendance at Colorado schools, who have asked for clarity in the requirements specific to their enrolled students.

The Department remains committed to fully engaging its stakeholders during this rulemaking process. Stakeholders that were notified of this rule-making included members of the public/parents, local public health agencies, federally qualified health centers, community health clinics, rural health centers, private physician offices and clinics, colleges and universities with housing, directors of school health at Colorado colleges and universities, Colorado Student Health Services Consortium, the Department's Immunization Workgroups, Vaccines for Children providers, Colorado Immunization Information System (CIIS) users, the Colorado Medical Society, the Colorado Chapter of the American Academy of Pediatrics, the Colorado Academy of Family Physicians, the Colorado Children's Immunization Coalition as well as local immunization coalitions, the Children's Campaign, Voices for Vaccines, and the National Vaccine Information Center.

Summarize Major Factual and Policy Issues Encountered and the Stakeholder Feedback Received. If there is a lack of consensus regarding the proposed rule, please also identify the Department's efforts to address stakeholder feedback or why the Department was unable to accommodate the request.

The Department's outreach to stakeholders has been ongoing with open communication among all stakeholder groups. To date, the proposed amendments have not generated any controversy.

Please identify health equity and environmental justice (HEEJ) impacts. Does this proposal impact Coloradans equally or equitably? Does this proposal provide an opportunity to advance HEEJ? Are there other factors that influenced these rules?

The proposed amendments apply equally and equitably to all Colorado students enrolled in schools and, as well as parents of students enrolled in schools. The proposed rule amendments promote health equity as they are meant to clarify and streamline the rules so they are more easily understood by school nurses, childcare health consultants, health care providers, local public health agencies and other staff who ensure that students are appropriately vaccinated for attendance at Colorado schools. In turn, this will support school and childcare staff who must communicate the requirements to their enrolled students and parents. It is anticipated that broader understanding of the rule requirements will lead to greater compliance and increased immunization rates at Colorado's schools, which could reduce the incidence of vaccine preventable disease. There are no environmental justice impacts.

10 II. Exemptions from Immunization

11
12 It is the responsibility of the parent(s) to have his or her student immunized unless the
13 student is exempted. A student may be exempted from receiving the required immunizations
14 in the following manner:

16 A. Medical exemption - By submitting a medical exemption form with the
17 statement of medical exemption signed by an advanced practice nurse or
18 physician licensed to practice medicine or osteopathic medicine in any state
19 or territory of the United States indicating that the physical condition of the
20 student is such that immunizations would endanger his/her life or health or is
21 medically contraindicated due to other medical conditions. This form is to be
22 submitted once, and must be maintained on file at each new school the
23 student attends.

25 B. Religious exemption - By submitting a nonmedical exemption form signed by
26 the parent(s) or the emancipated student indicating that the parent(s) or
27 emancipated student is an adherent to a religious belief whose teachings are
28 opposed to immunizations.

31 1. Prior to kindergarten entry, a nonmedical exemption form must be

217 **IX. Requirements for college and university students, colleges and universities.**
218 The provisions below apply only to colleges or universities, or students enrolled in a college or
219 university.
220
221 A. Exemptions from immunization
222
223 A college or university student may be exempted from receiving required
224 immunizations in the following manner:
225
226 1. Medical exemption - by submitting a medical exemption form with the
227 statement of medical exemption signed by an advanced practice nurse
228 or physician licensed to practice medicine or osteopathic medicine in
229 any state or territory of the united states indicating that the physical
230 condition of the college or university student is such that
231 immunizations would endanger his/her life or health or is medically
232 contraindicated due to other medical conditions. This form is to be
233 submitted once, and must be maintained on file at each new school the
234 college or university student attends.
235
236 2. Religious exemption - by submitting a nonmedical exemption form
237 signed by the college or university student 18 years of age or older, the
238 parent if the college or university student is under 18 years of age, or
239 the emancipated college or university student indicating that the
240 college or university student, parent or emancipated college or
241 university student is adherent to a religious belief whose teachings are

242 opposed to immunizations. As of July 1, 2016, beginning with college or
243 university entry, a nonmedical exemption form must be submitted at
244 enrollment.
245

246 3. Personal belief exemption - by submitting a nonmedical exemption form
247 signed by the college or university student 18 years of age or older, the
248 parent if the college or university student is under 18 years of age, or
249 the emancipated college or university student indicating that the
250 college or university student, parent or emancipated college or
251 university student has a personal belief that is opposed to
252 immunizations. As of July 1, 2016, beginning with college or university
253 entry, a nonmedical exemption form must be submitted at enrollment.
254

255 4. In the event of an outbreak of disease against which immunization is
256 required, no exemption or exception from immunization shall be
257 recognized and exempted persons may be subject to exclusion from
258 school and quarantine.

259 B. Minimum immunization requirements
260

261 1. Two valid doses of the Measles, Mumps and Rubella vaccine are required for
262 all college or university students, unless the college or university student
263 was born before 1957, or the college or university student can provide
264 laboratory confirmation of disease as a criterion for acceptable evidence of
265 immunity for Measles, Rubella, and Mumps.
266

267 2. Pursuant to Section 25-4-901, C.R.S. et. seq., and Section 23-5-128 (3),
268 C.R.S., each college and university shall provide information concerning
269 Meningococcal disease and Meningococcal vaccine to each new college or
270 university student residing in student housing, or if the college or university
271 student is under 18 years, to the college or university student's parent or
272 guardian. College and university students residing in student housing who
273 have not received a Meningococcal vaccine within the last five years shall
274 review the information concerning Meningococcal disease and
275 Meningococcal vaccine. If the college or university student does not obtain
276 a vaccine, a signature must be obtained from the college or university
277 student or if the college or university student is under 18 years, the college
278 or university student's parent or guardian indicating that the information
279 was reviewed and the college or university student or college or university
280 student's parent or guardian has declined the vaccine.

281 C. Examination and audit of official school immunization records
282

283 The Department of Public Health and Environment's representative shall have
284 the right to audit and verify records to determine compliance with the law.
285 Discrepancies found through audits shall be corrected by school officials, and
286 any college or university student not in full compliance shall be denied
287 attendance from school according to the rules in Section IX (D).

1. A college or university student who is: not in-process, not appropriately vaccinated for his/her age, or not exempt shall be denied attendance in accordance with the law.
 2. A school official shall deny attendance from school, pursuant to the provisions established by the college or university, any college or university student not in-process, not appropriately immunized for his/her age, or not exempt per Section 25-4-903, C.R.S. no college or university student shall be denied attendance for failure to comply unless there has been a direct personal notification of noncompliance by the appropriate school authority to the college or university student's parent or guardian, the emancipated college or university student or the college or university student 18 years of age or older.
- E. Official school immunization records
1. Official school immunization records shall include one of the following:
 - A. An official certificate of immunization or an alternate certificate of immunization approved by the Department of Public Health and Environment, which shall include one of the following forms of documentation with the dates and types of immunizations administered to a college or university student:
 1. A paper or electronic document that includes information transferred from the records of a licensed physician, registered nurse, or public health official, or
 2. An electronic file or hard copy of an electronic file provided to the school directly from the immunization tracking system established pursuant to Section 25-4-2403 C.R.S. or from a software program approved by the department of public health and environment, or
 - B. An official medical exemption form with the date and vaccines exempted from, or
 - C. An official nonmedical exemption form with the date, type of exemption taken and the vaccines exempted from.
 2. Any immunization record (original or copy) provided by a physician licensed to practice medicine or osteopathic medicine in any state or territory of the united states, registered nurse, or public health official may be accepted by the school official as proof of immunization.
 3. Schools shall have on file an official school immunization record for every college or university student enrolled.
