- 2. On August 15, 2025, the Hearing Officer denied Respondent's Second Motion to Dismiss and granted Respondent's request for a continuance "in order to be represented by

an attorney." Order at 2 (Aug. 15, 2025). The Hearing Officer re-set the hearing for September 23, 2025.

3. Since then, the parties have engaged in settlement negotiations in an effort to reach a negotiated resolution to the allegations in the Division's Complaint. To date, the

parties have not been able to reach an agreement.

4. Due to a longstanding commitment, undersigned counsel, who is counsel of

record for the Elections Division in this matter, is out of the office on September 23, 2025,

and unable to participate in a hearing that day.

5. Accordingly, the Division respectfully requests an order continuing the

hearing to a date in October.
