STATEMENT OF SUFFICIENCY 2023-2024 Proposed Initiative #89 "Right to Abortion"

May 17, 2024

On April 18, 2024, the designated representatives of 2023-2024 Proposed Initiative #89 ("Right to Abortion") submitted 225,688 petition signatures to the Elections Division of the Secretary of State's office. Because Proposed Initiative #89 proposes to change the Colorado constitution, the petition must contain signatures from each state senate district equal to two percent of the total registered electors from each respective district, in addition to meeting the 124,238 threshold.¹
