### Notice to Colorado Legislature, Officials and Businesses

# I, \_\_\_\_\_\_, one of the People (as seen in Article 2 Section 1 of the Colorado Constitution), Sui Juris, am serving you with due

notice, that you may provide due care;

Please take notice that there has been an error in understanding and that the People of Colorado, actually created the State of Colorado, and created the frame of government and its seats, and that the government does not give rights to the People, nor can the government write Legislation that would remove or abrogate the rights of the People (please see the preamble to see the original intent of the People below):

#### Colorado Constitution Preamble:

In order to assert our rights, acknowledge our duties, and proclaim the principles upon which our government is founded, we declare:

Please take notice that our rights are to be asserted, which is a duty of the people and to give the government an outline of how to not infringe on these God given rights. In the Colorado Constitution you have sworn to some things that may have been undisclosed to you by attorneys as there may be a vast amount of liability incurred if you are made aware of these principles. For instance, the People have all Political Power, the government was created based off of our will only and you were only put here to be trustees and servants to benefit the People (Please See the Constitutional Provision Below);

# Colorado Constitution Section 1: Vestment of Political Power

All political power is vested in and derived from the people; all government, of right, originates from the people, is founded upon their will only, and is instituted solely for the good of the whole.

Please take further notice that if the government has all its power, that is of right, coming directly from the people, and it's based on the People's will only, that any decisions made must also be based on the will of the People, and not the based on the will and thoughts of their hired servants and trustees. Therefore, it is my wish and will for you as a Public Servant, to show where in the Constitution you were given the power to prohibit any third party from having any access to all voting equipment in Colorado?

#### **Colorado Constitution Section 2:**

People May Aiter or Abolish Form of Government Proviso

The people of this state have the sole and exclusive right of governing themselves, as a free, sovereign and independent state; and to alter and abolish their constitution and form of government whenever they may deem it necessary to their safety and happiness, provided, such change be not repugnant to the constitution of the United States. [Emphasis by Highlight Added]

Please understand that it is our right to be happy, safe, and free from anyone dictating to the People what may be done with their election process. It is the wish of I, as one of the People, that any action infringing on the right of the People to verify the integrity of the election process, including access by third parties, and that all such power is vested in the legislature (see Article VII, Section 11, purity of elections) and is solely responsible for the purity of elections, I, as one of the people, am looking for the Legislature to correct this, and then it is my intent to go to the People and remove all powers and authority which are against the will of the People! Please take notice that the Secretary of State is nowhere authorized by the People to change the Colorado Constitution which you swore to uphold:

Colorado Constitution Article XV Section 3: Power to Revoke, Alter or Annul Charter.

The general assembly shall have the power to alter, revoke or annul any charter of incorporation now existing and revocable at the adoption of this constitution, or any that may hereafter be created, whenever in their opinion it may be injurious to the citizens of the state, in such manner, however, that no injustice shall be done to the corporators. [Emphasis by Highlight Added]

Colorado Constitution Article VII Section 11: Purity of Elections.

The general assembly shall pass laws to secure the purity of elections, and guard against abuses of the elective franchise.

I look forward to your speedy attention to these issues and look forward to the immediate corrective Action that follows the powers and duties you were given in your Trust Indenture, the Colorado Constitution.
