Secretary of State Griswold,

I am a Petitioner to contest legal and/or Constitutionality of Temporary/Emergency Rule Amendments to Rule 20.5.4 including new Rules 20.5.4(a) and 20.5.4(e); Amendments to Rule 21.7.3 including a portion of Former Rule 21.7.3 which has been re-codified as New Rule 21.7.3(a); and Adoption of New Rules 21.7.3 (b-e) and 21.7.4 ("Petition")

I am also a Colorado Native born in the state in 1952. I signed in and observed the Webinar last week for the entire 4 hours.
